

Community-Wide plan to address AOD issues at local level. Development of this plan is a process to:

- Identify problems through needs assessments, data collection, community input
- Develop & prioritize clear concise problem statements
- Develop measurable and realistic goals

The Comprehensive Community Plan (Continued)

- Develop objectives to address identified problems
- Advocate for change through the release of funds to local agencies and by influencing policies & enforcement
- Evaluate the progress & redirect if needed
- Report findings to state via annual plan updates

#1: Youth and Adults in Scott County use and abuse Alcohol

Goals:

- Reduce the rate of youth alcohol consumption as reported by the 2016 IPRC Indiana Alcohol, Tobacco and Other Drugs Survey.
- 2. Reduce the rate of adult alcohol consumption as reported by the justice system, 2016.

Aleohol Prevalence in Indiana

Alcohol is the most frequently used drug in Indiana and the US

Among Hoosiers ages 12 and up, 51.2% drank alcohol in the past month, and 24% engaged in binge drinking

Young adults ages 18-25 had the highest rates of alcohol use in IN; 61.8% reported current alcohol use, and 43.1% reported binge drinking





Scott County 2013 Dept. of Child Services Data

244 children were in out-of-home care, 75% of which were a result of substance abuse by caregiver

There were 117 removed in 2013 and they are included in the 244 above

104 of the children had been removed previous to 2013 and continue to be in out-of-home care due to the continued substance abuse of caregiver

Survey for Alcohol Compliance

In 2012 IN Excise Officers conducted 9978 inspections across the State of Indiana and had 504 failures, a 5.204% failure rate

Scott County had the highest failure rate at 40%

The following businesses failed their SAC Inspections: Bull's Cork and Bottle, Puerto Vallarta, RCP Marketing LLC, and Roadhouse USA

In 2013 there were no "Alcohol Compliance
Checks" in Scott Co by Indiana Excise Officers

#2: Youth and Adults in Scott County
Use and Abuse Tobacco Products and
Marijuana

Goals:

- 1. Reduce the percentage of Scott County youth using tobacco and marijuana by 2% in each grade 6-12 based upon reports from the IPRC Survey by 2016.
- 2. Scott County will have at least one adult cessation program each year and will increase citizen annual use of the Indiana 1-800 QUIT NOW line, compared to the past three years.

Tobacco Prevalence in Indiana

1/3 of Hoosiers ages 12 and up used a tobacco product in the past month (32.9%)

Highest tobacco use rate in state was among 18 to 25 year olds (44.7%)

More than 1/4 (26.8%) of Hoosiers ages 12 and up smoked cigarettes in past month and nearly 1/4 of all Hoosiers ages 18 and up use cigarettes every day

Indiana's adult smoking prevalence (24%) is the 6th highest in the nation

Marijuana Prevalence in Indiana

Marijuana is the most commonly used illicit substance in Indiana and the nation


Highest rate of current past month use was among 18 to 25 year olds (16.8%)

20% of Indiana high school students currently use marijuana


7.1% of 8th grade students, 13.7% of 10th grade students, and 17.6% of 12th grade students currently use marijuana

- 2014 County Health Rankings, Scott Co. adult smoking rate = 25% with 4,500 adults smoking
- Tobacco users calling the IN Quitline: 173 in 2010,
 68 in 2011, 29 in 2012, and 64 in 2013
- ► IN State Excise Police: Scott County TRIP (Tobacco Retailer Inspection Program) Results:
 - 2012 Noncompliance Rate = .09%, Austin Supermarket, Save A Lot, and Murphy USA failing
 - ► 2013 Noncompliance Rate = 12.03%, 12 stores Failed: Austin Supermarket, Austin Fuel Mart, LeRoy's Food Mart, Colwell Convenience, Low Bob's Discount Tobacco, Speedway, Pioneer Village, Casey's General Store, Austin Sunoco, Swifty Food Mart, WalMart, Circle K

CIGARETTES: % of Monthly Use by Grade SCSD 2 only, 2014 Mean Age of First Time Use = 13.3




CIGARETTES: % of Monthly Use Comparison of Grade in 2010/2011/2012/2013/2014, Scott Co Students



SMOKELESS TOBACCO: % of Monthly Use by Grade SCSD 2 only, 2014 Mean Age of First Time Use = 13.6




SMOKELESS TOBACCO: % of Monthly Use Grade in 2010/2011/2012/2013/2014, Scott Co Students

The Scott County Prosecutor's Office will reduce tobacco infraction tickets if the offender completes a tobacco prevention/cessation related class (TAP/TEG)

The county schools are to turn over issues with tobacco users to law enforcement for documented violations and further referral to TAP/TEG

#3: Youth and Adults in Scott County use and abuse prescription medications

Goals:

- Reduce the number of annual drug overdose deaths in Scott County to 0 by 2017.
- 2. Reduce the number of controlled substances dispensed in Scott County by 25% by 2017.

Prevalence of Prescription Drugs in IN

The 3 most commonly abused types of Rx medicine are pain relievers (opioids), central nervous system depressants (sedatives, tranquilizers, hypnotics), and stimulants (used to treat ADD)

In 2012 nearly 10.7 million Controlled Substances were dispensed to Indiana residents

Young Hoosiers ages 18-25 had the highest rate of past year use (13.5%)




Controlled Substances

The number of controlled substances dispensed in Scott County decreased for the first time in a four-year period. In 2012, over 20,000 fewer controlled substances were dispensed than 2011, a decrease of nearly 25%, marking the fewest number of controlled substances dispensed during the 4-year period

IC 5-2-11

- Monies collected through the courts are held in a county drug free communities fund by the county auditor
- The Local Coordinating Council (CEASe) is the administrator of these funds & is responsible for its distribution back into the community according to their approved Comprehensive Community Plan
- Grants are awarded to agencies & entities based on needs/services identified by the LCC through its comprehensive planning process

CEASE SUPPORTS

- Prevention/Education initiatives, emphasizing the use of evidence-based programs in the prevention of substance use & the education of the general public regarding substance use/abuse in the county.
- Treatment/Intervention programs designed to identify & assist those who have substance abuse issues secure and benefit from service providers.
